DISTINGUISHED HONOREES

LEE GELERNT

Lee Gelernt, an attorney at the ACLU since 1992, currently is the Deputy Director of the ACLU's national Immigrants' Rights Project, and Director of the Project's Program on Access to the Courts. He has argued numerous groundbreaking cases establishing the constitutional and statutory rights of non-citizens, in the areas of discrimination, education, due process and access to the courts. Since 2001, Mr. Gelernt also has worked on several far-reaching national security cases arising out of the events of September 11. For example in March 2011, he argued *Ashcroft v. al-Kidd* in the U.S. Supreme Court, which challenged the constitutionality of the government's post 9/11 use of the material witness statute to investigate and preventively detain terrorism suspects, when there is no probable cause to justify a criminal arrest.

Mr. Gelernt served as one of the few human rights observers at Guantanamo Bay for the first military trial conducted by the United States since World War II. He has testified before the U.S. Senate on habeas corpus and judicial review issues. He also is a lecturer-in-law at Columbia Law School and a visiting lecturer in clinical law at Yale Law School.

Mr. Gelernt is a 1988 graduate of Columbia Law School, where he was a Notes and Comments Editor of the Law Review. After graduation, he served as a law clerk to the late Judge Frank M. Coffin of the First Circuit U.S. Court of Appeals. In 2002, he received the 13th Annual Public Interest Achievement Award from Columbia University's Public Interest Law Foundation. The American Immigration Lawyers Association has twice awarded him their national prize for excellence in litigation. He is a frequent guest speaker at law schools and conferences around the country, and regularly appears in the national and international media.

PHILIP M. GENTY

Philip M. Genty is the Everett B. Birch Innovative Teaching Clinical Professor in Professional Responsibility at Columbia Law School and has been a clinical professor at Columbia since 1989. His research and teaching interests are in professional responsibility, clinical education, prisoners' rights, family law, and appellate advocacy. Professor Genty also directs the first year Legal Practice Workshop and Columbia's Moot Court program. He is the recipient of the 2008 Willis L.M. Reese Prize for Excellence in Teaching.

After graduating from law school, Professor Genty was an attorney at Prisoners' Legal Services of New York; the New York City Department of Housing, Preservation and Development; and the Bedford-Stuyvesant Community Legal Services Corporation. He joined the faculty of Brooklyn Law School in 1987, where he taught legal writing and a seminar on the rights of prisoners.

Professor Genty has consulted with clinical legal education programs in Central and Eastern Europe and Israel. He also has assisted with legal resource materials for incarcerated parents and works with several organizations that assist women prisoners. He serves on the Columbia University Senate's Education Committee.

The Center for Public Interest Law (now Social Justice Initiatives) opened on January 3, 1993. One of the first law school offices in the nation dedicated to public interest employment and pro bono service, CPIL originated with members of the Class of 1992 who identified the need and organized to make it a reality. They found ready and powerful allies in the Board of Visitors' Public Interest and Pro Bono Opportunities Committee, which helped them develop and promote their ideas. An energetic new Dean appointed a faculty-student committee, which persuaded the full faculty to adopt the mandatory pro bono requirement and create CPIL. The students' twelve-page memorandum about what the office could do and numerous consultations with them guided CPIL's work for many years. These are the people who made it happen:
